Benefits Spotlight Life Insurance-The Hartford

The District provides employer-paid life insurance for up to 150% of your base annual salary up to \$100,000. All full time active and regular part time employees & board members are eligible for coverage. Retirees are eligible to age 66.

In addition to the monetary benefits paid to the named beneficiary, other life insurance benefits include:



Dependent Life Insurance*

Spouse: \$1000

Dependent Children:

Less than 6 month(s)
of Age \$100

6 months of age or
older \$500

Living Benefits Option*

Should you be diagnosed as being terminally ill with a 12 month or less life expectancy, the *Living Benefits* option allows you to receive an accelerated payment of a portion of your life insurance.

Life Insurance Conversion Options

If your insurance or a portion thereof, terminates, the conversion option allows you to convert all or a portion of your group coverage to an individual policy from the Hartford Life. You must request conversion and pay the required premium within 31 days of the date your insurance ends. This option applies

to benefit-eligible employees separating from Peralta employment and retirees who attain age 66.

More information (how to submit a claim, how to convert) can be found in the *Life, Accidental Death and Dismemberment and Dependent Life Certificate* being mailed to the home address for each eligible employee and retiree.

Long-Term

The District provides employer-paid disability benefits for benefit-eligible employees who are off from work and under medical care for 90 days or longer. The benefits:

Wage replacement

Up to 60% wage replacement to a monthly maximum of \$5000.

Survivor Income Benefit

If you die while receiving benefits under this plan, a survivor benefit will be payable to your spouse, children or estate. This benefit is one payment of three times your monthly benefit.

Travel Assistance

If traveling 100 miles or more from home, Worldwide Assistance Services, provides 24-hour toll-free emergency services.

Disability Insurance-

- Emergency Medical Assistance
- Emergency Personal Services
- Pre-Trip Planning Information
