Timeline for Perkins IV Program Years 2014-15, and 2015-16

for MIS Data Submission, Perkins Reporting, Certification, and Allocation Determination

The following timelines provides important dates and deadlines for the Perkins allocation process. *Dates provided are subject to change by the Chancellor's Office (CO).* Deadlines for districts that impact Perkins Title I, Part C (I-C) allocations are indicated as bold text. Fiscal report dates are indicated in red, however, the Legal Terms and Conditions, Article I, Section 3 notes that: *all reports that fall on a weekend or a holiday are due by close of business on the last working day prior to the reporting deadline.* Extensions of reporting deadlines may be made with the approval of the Project Monitor.

| October 1, 2015 | District 2014-15 Financial Aid data due to the CO Failure to submit complete and accurate 2014-15 Term or Financial Aid data by the February 12, 2016 deadline may have a negative effect on your Perkins allocation. Districts have the opportunity to correct data submitted for Perkins Title I-C funding purposes until the deadline. MIS data resubmissions after February 12, 2016 are not used for Perkins Title I-C allocations. |
| October 15, 2015 | 1st Qtr. Report for program year 2015-16 is due. |
| Nov. 16-17, 2015 | BOG to approve 2016-17 Career Technical Education Expenditure Plan |
| December 1, 2015 | This is the deadline for resubmission of 2014-15 Financial Aid data for use in the SFA reconciliation for 2015-16 BFAP-SFAA administrative funding. |

| January 15, 2016 | 2nd Qtr. Report for program year 2015-16 is due. |
| February 2016 | First Principal Apportionment (P1) includes Recalculation Apportionment based on districts' 2015-16 Final Reports of Expenditures. |
| February 19, 2016 | This is the deadline for resubmission of MIS data for use in 2016-17 Perkins funding allocation. To meet district planning and state funds distribution requirements, the first certification of the counts of economically disadvantaged CTE students must occur in February. It is critical that resubmissions and certifications occur within the scheduled timeline to provide sufficient planning time for districts. |
| February 19, 2016 | District certification form is due in the CO indicating data certification or resubmission (requests new certification form). |
| February 24, 2016 | This is the date of the final run of Perkins Title I-C Section 132 Reports #1 & #2 by CO MIS. |
| February 29, 2016 | Perkins Title I-C Section 132 Reports #1 & #2 are posted to web (new certification forms for districts with resubmissions will also be posted). |
| March 7, 2016* | Tentative 2016-17 Allocations for Perkins Title I-C are posted to web. |
| March 14, 2016* | 2016-17 Perkins Title I-C District Local Application (online) opens for data entry. |
| March 28, 2016 | Resubmission certification form is due for districts submitting data to correct counts before February 19, 2016. |
| April 15, 2016 | 3rd Qtr. Report for program year 2015-16 is due. |
| May 16, 2016 | The 2015-16 Perkins Title I-C District Local Application (online) is due. |
| July 1, 2016 | Perkins 2016-17 Title I-C grants become effective. District Applications must be substantially approved by the CO prior to July 1, 2016 for expenditures to begin. |
| July 15, 2016 | 4th Qtr. Report for program year 2015-16 is due |
| August 31, 2016 | Title I-C Final Report for program year 2015-16 is due. |
